New York 'Election Deniers' Move a Mountain

In a stunning victory for New York Citizens Audit's 2,000 volunteers (NYCA), the New York State Board of Elections (NYSBOE) is quietly auditing the county and state voter rolls. After four contentious years of hiding the truth revealed by NYCA's extensive analysis, the NYSBOE has admitted there is a massive problem.

A confidential text message from Jennifer Wilson, Deputy Director of Public Information at NYSBOE, anonymously leaked to NYCA, reads:

"NYSVoter Full Audit

The state board is working on a full audit of voter records (active, inactive and pre-reg voters only) in NYSVoter to ensure they match county records within your local registration systems."

NYCA Executive Director Marly Hornik exclaimed, "We did it! After being relentlessly attacked by the state Attorney General, officials, and so-called journalists, NYCA's volunteers are vindicated in taking concerns about New York's corrupt voter rolls to the State Police Special Investigations Unit, FBI, 500 town boards, twenty counties, and over a hundred state legislators. It's a tiny step in cleaning up the shameful mess NYSBOE has made of New Yorkers' right to choose representatives."

NYCA's forensic audit of New York's 2022 midterm found 5,808,232 registrations with "material omissions and errors," as defined in the Civil Rights Act of 1964. These "voters" cast 729,208 improperly counted votes, helping elect 27 members of Congress. NYCA's subsequent report, "New York's Reign of Error," resulted in a tidal-wave of state and media attacks, and a criminal investigation by Attorney General Letitia James, who was also elected in 2022.

The lawfare spurred Hornik and national cyber expert Harry Haury to found United Sovereign Americans, where they took the NYCA process for audits by credentialed volunteers to 21 states. USA has now filed nine federal lawsuits. USA also extended the NYCA analysis, using official records of voter registration, participation, and identity verification to study whether "voters" existed.

"The shocking results for New York showed that 128,986 voters who voted in 2022 likely do not exist, and 984,830 voters did not live at the address they voted from," stated Hornik. "Combined with the 35,312 votes counted with NO associated voter whatsoever, a whopping 19.3% of the 2022 vote in New York was improper. Our small business economy has been devastated, public education is a woke mess, crime is skyrocketing, marijuana dispensaries on every corner are the new opium dens, people fleeing the state in droves are replaced by illegals—did New Yorkers vote for this?"

A study of illegally duplicated records shows 2,200 double votes in 2022, and 245,000 double votes in 2020, bolstering NYCA's longstanding concern that NYSVoter is splitting at the seams with election misconduct. A Staten Island Grand Jury Report from 2022 agrees.

"New York Citizens Audit is a miracle for a state mired in corruption scandals," concluded Hornik. "We presented the election misconduct facts calmly, accurately, and powerfully from Montauk to Buffalo, and the mountain is finally moving. The spirit of liberty from the American founding is rekindled. Go NYCA!"
